No	Third Parties to whom disclosure is made for the purpose stated in the PDP Notice
1	Medical Specialists who run clinics and treat the Data Subject (Patient) in the Hospital
2	Insurance Companies that manage payment obligations of the Patient
3	Managed Care Organizations (MCOs) that act as intermediary between employers and Insurance Companies in the payment process (i.e. TPAs, HMOs, Corporate Healthcare Administration)
4	Parents and Next of kin as permitted by the Patient
5	Debt recovery agents to recover outstanding debt owed to the Data Controller (Avisena)
